Measure Description: The percentage of deliveries of live births between October 8 of the year prior to the measurement year and October 7 of the measurement year. For these women the measure assesses the following facets of prenatal and postpartum care:

- **Prenatal Care in the First Trimester**: The percentage of deliveries that received a prenatal care visit as a member of the organization in the first trimester, on or before the enrollment start date or within 42 days of enrollment in the organization. Care occurring on the date of enrollment is considered adherent.
- **Postpartum Care**: The percentage of deliveries that had a postpartum visit on or between 7 and 84 days after delivery.

Eligible Population

There is no specified age range. All live deliveries are included.

Product Lines

Commercial, Medicaid

Data Collection Method

Administrative (claims), Supplemental data, hybrid (medical record)

Note: The PPC measure is hybrid. Any care not received via claims during the measurement year will result in medical record requests during the HEDIS medical record review project.

Exclusions

Members are excluded from the measure if they meet the following criteria:

• Members who are in hospice.

Measure Compliance (numerator)

Numerator 1 - Timeliness of Prenatal Care

A prenatal care visit in the first trimester, on or before the enrollment start date or within 42 days of enrollment in the plan, including the day of enrollment.

Numerator 2 – Postpartum Care

A postpartum visit on or between 7 and 84 days after delivery. For postpartum visits, either a postpartum visit code or a cervical cytology code satisfies the HEDIS requirement.
