

Adult Immunization Status (AIS-E)

HEDIS® Measurement Year 2024 Electronic Clinical Data Systems (ECDS) Measure

Measure Description: The percentage of members 19 years of age and older who are up to date on recommended routine vaccines for influenza, tetanus and diphtheria (Td) or tetanus, diphtheria and acellular pertussis (Tdap), zoster and pneumococcal.

*Please Note: Age varies based on immunization.

Eligible Population

Ages 19 years of age and older.

Exclusions

Members are excluded from the measure if they meet the following criteria:

• Members who are in hospice.

Measure Compliance (numerator)

Numerator 1 – Immunization Status: Influenza

• Members 19-65 years of age who received an influenza vaccine on or between July 1 of the year prior to the measurement period and June 30 of the measurement period.

Numerator 2 – Immunization Status: Td/Tdap

 Members 66 years of age and older who received at least one Td vaccine or one Tdap vaccine between nine years prior to the start of the measurement period and the end of the measurement period.

Numerator 3 – Immunization Status: Zoster

 Members 50-65 years of age who received at least one dose of the herpes zoster live vaccine or two doses of the herpes zoster recombinant vaccine at least 28 days apart, any time on or after the member's 50th birthday and before or during the measurement period.

Numerator 4 – Immunization Status: Pneumococcal

 Members 66 years of age and older who were administered at least one dose of an adult pneumococcal vaccine on or after the member's 19th birthday and before or during the measurement period.
