Electronic Clinical Systems (ECDS) Measure

Measure Description: Members 45 to 75 years of age who had appropriate screening for colorectal cancer. Appropriate screenings are defined by one of the following:

- Fecal occult blood test (FOBT) during the measurement year.
- Stool DNA (sDNA) with FIT test (Cologuard®) during the measurement year or two years prior to the measurement year.
- Computerized tomography (CT) colonography during the measurement year or the four years prior to the measurement year.
- Flexible sigmoidoscopy during the measurement year or the four years prior to the measurement year.
- Colonoscopy during the measurement year or the nine years prior to the measurement year.

Eligible Population

Members 45 to 75 years of age as of December 31 of the measurement year.

Product Lines

Commercial, Medicaid, Medicare

Data Collection Method

Administrative (claims) and Supplemental data.

Exclusions

Members are excluded from the measure if they meet the following criteria:

- Members who are in hospice or palliative care.
- Members with a history of colorectal cancer or a total colectomy any time through December 31 of the measurement year.
- Members 66 years of age and older as of December 31 of the measurement year with a frailty and advanced illness diagnosis during the measurement year.

Measure Compliance (numerator)

Appropriate screenings are defined by one of the following:

- Fecal occult blood test (FOBT) during the measurement year.
- Stool DNA (sDNA) with FIT test (Cologuard®) during the measurement year or two years prior to the measurement year.
- Computerized tomography (CT) colonography during the measurement year or the four years prior to the measurement year.
- Flexible sigmoidoscopy during the measurement year or the four years prior to the measurement year.
- Colonoscopy during the measurement year or the nine years prior to the measurement year.
