

Measure Description: The percentage of children who turned 2 years of age during the measurement year and had the following vaccinations, with different dates of service, on or by their second birthday: DTaP, IPV, HepB, HiB, HepA, MMR, VZV, PCV, RV, and Influenza.

Eligible Population

Children turning 2 years of age during the measurement year.

Product Lines Commercial, Medicaid

Data Collection Method

Administrative (claims), Supplemental data, Hybrid (medical record)

Note: The CIS measure is hybrid. Any care not received via claims during the measurement year will result in medical record requests during the HEDIS medical record review project.

Exclusions

Members are excluded from the measure if they meet the following criteria:

- Members who are in hospice.
- Members who had a contraindication to a childhood vaccine on or before their 2nd birthday.

Measure Compliance (numerator)

The measure calculates a rate for each vaccine and three combination rates.

<u>MMR</u> – One measles, mumps and rubella vaccine on or between the child's first and second birthday, or history of measles, mumps or rubella.

HepB – Three hepatitis B vaccines on different dates of service, or history of hepatitis illness.

VZV – One varicella zoster e.g., chicken pox vaccine on or between the child's first and second birthday, or history of varicella zoster illness.

HepA – One hepatitis A vaccine on or between the child's first and second birthday, or history of Hepatitis A illness.

Influenza – At least two influenza vaccinations. Vaccines administered prior to 6 months do not count. The LAIV vaccination must occur on child's second birthday.

Measure Compliance (numerator), continued

The following vaccines, if administered prior to 42 days after birth, do not count:

DTaP - Four diphtheria, tetanus, and acellular pertussis vaccines on different dates of service.

IPV – Three polio vaccines on different dates of service.

HiB - Three haemophiles influenza type B vaccines on different dates of service.

PCV - Four pneumococcal conjugate vaccines on different dates of service.

<u>**RV</u>** – Two or three dose rotavirus or at least one dose of the two-dose rotavirus vaccine and at least two doses of the three-dose rotavirus vaccine on different dates of service.</u>

Combination 3 – Numerator compliant for DTaP, IPV, MMR, HiB, HepB, VZV, and PCV vaccines.

<u>Combination 7</u> – Numerator compliant for DTaP, IPV, MMR, HiB, HepB, VZV, PCV, HepA, and RV vaccines.

Combination 10 – Numerator compliant for all ten vaccines.
